## The State of the Art of Research on Cultural Policy in the countries of South East Europe - a Policies for Culture statement<sup>1</sup>

---

**A new era for cultural policy.** Cultural policies in the countries of South East Europe – i.e. Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Macedonia, Moldova, Romania, Serbia & Montenegro – have entered a new era. This new era is marked by several factors: the rising exposure of culture to a competitive market environment, the growth of non-governmental organisations and other new stakeholders in culture, the changing relationships between culture and other sectors and policies, and the enlarged European Union in the neighbourhood.

**A must for research.** The new policy landscape – which is more complex and challenging than ever before – requires the production of new knowledge through its most certain form, i.e. research.

**Deficiency of policy knowledge.** Policy knowledge produced in the SEE countries, however, is rarely generated through research. Moreover, an anti-research climate has taken hold and some institutes or centres are closed or have had their activities considerably reduced. At the same time, other sources of information, mostly gathered routinely through administrative channels and collegial meetings, serve as the main basis for policy making. This exacerbates the issue of validity of information, especially when different stakeholders in the policy-making process take different or opposing views. On the other hand, the impact of policy decisions, including new legislation, such as studying policy feedback or policy learning, i.e., what, how or why certain things should (or should not) be taking place, is rarely an object of scrutiny.

**Questionable evaluation.** The lack of independent research deteriorates the quality of information about policy, which serves as a basis for policy evaluation. For example, have, or in what degree, have the objectives of a policy been achieved? In lieu of measurable standards or criteria, very often apologetic self-indulgence or disqualifying criticism of such a policy, makes for the basis of evaluation.

**Questionable competence.** The competence of a policy adopted without research support becomes questionable in its interfaces with other policies whose sources are more research informed and also with international partners.

**Incomplete legitimacy.** The legitimacy of cultural policy not based on research derives leans on political authority or populism of the general constituency, rather than on cultural stakeholders and specific cultural publics.

**Responsibility of researchers.** Responsibility for such an anti-research climate lies with the of broader research community too. Its interests in cultural policy research is relatively weak and those research institutions that do exist are not adequately equipped with research knowledge and experts. NGOs in culture and neighbouring areas are also responsible as they underestimate the role of research in democratic and participating policy making.

**To overcome impediments.** In order to remove the walls between the policy community and the research community several steps should be taken:

- to enable actually existing and specialised research institutes or centres to get involved in making cultural policy research of different types (comparative policy analyses, observations, surveys, focus groups interviews, content and discourse analysis, cultural economy studies, etc.);
- alternatively, to contract out research based on big or representative samples (e.g., public opinion surveys), or other research too complex or expensive for a cultural research centre to carry out;
- to promote and facilitate the development of research capacities in each of the SEE countries;
- to set up databases on cultural policies, whose data can be used in longitudinal (future) and comparative (international) research;
- to substantially improve cultural statistics by supplementing specific cultural topics and analytical requests to ordinary methodology of data gathering and data-analysis provided by state offices for vital and similar statistics;
- to combine internationally (European) matching sources for financially funding policy research in individual countries, most especially research co-operation between countries in the SEE region.
- to seek support from and develop stronger cooperation with research organisations from other European countries, as well as international organisations acting in the area of cultural cooperation and cultural policy, in view of supporting the local and regional initiatives in raising awareness and building legitimacy, in providing expertise and financial support.

# Background to the workshop

---

### The Task Force for Cultural Policy Research in SEE

In view of responding to the above-stated needs, challenges and opportunities, the Policies for Culture proposed the setup of the Task Force for Cultural Policy Research in South East Europe, in view of using the existing network of knowledge and expertise developed in the last four years throughout the region and addressing a level and a field which has been little addressed in its previous activities – that of research. In view of its further establishment, a Consultative Group of the Task Force has been set up<sup>2</sup> and a first development meeting took place in spring 2004. It is a result of this meeting and with the continuous support of the Consultative Group that the current workshop is being organised, in view of setting the future agenda of the PFC Task Force for Cultural Policy Research in SEE.

### The workshop

The present workshop represents the first larger activity of the Task Force, having four main objectives:

**Mapping:** To map out gaps arising between policy and research in individual SEE countries, as well as some good examples of productive partnerships between policy community and research community in SEE and other countries.

**Raising awareness:** To raise awareness of liabilities of the lack of research, on the one hand, and assets resulting from the policy supply with independent research results, on the other.

**Capacity building & networking:** To initiate – by incorporating research activity into the *Policies for Culture* action triangle – the development of research interests and capacities in SEE countries, which may be supported by SEE states as well as inter-governmental or non-governmental organisations, and which may further be upgraded, e.g. as a regional research network.

*(and the key objective of the workshop)*

**Setting an agenda:** To define most urgent topics of research as well as methodologies to be applied in order to easier convert research findings into policy papers which could have an impact on national and local level. The proposed agenda will also be submitted to the inter-governmental organisations active in this field, and particularly to UNESCO, the EU, the Council of Europe and the Central European Initiative.
